

# CREATE HIRE REQUEST (without a position)

This guide contains instruction on completing a hire request when a position number is not known.

This guide is intended for hiring managers (HM) and Unit Approver (UA) within the system. Unit Approver can <u>review this section</u> for specific tasks.

# Before You Begin

The process begins with review of the vacant position page to determine available positions.

If no position is available, the hiring manager will request through the submission of a Create Hire Request form. A position will not be created until it has been approved by the Unit Approver.

# Submission of Form

## Step 1 - **REQUIRED**

- Hiring Work Study?
  - o Indicate work-study when hiring a work-study student that applied to a work-study posting in Handshake.
    - Is this a LAEP hire?
      - For Learning-Aligned Employment Program (LAEP) hires, indicate "Yes". Only approved jobs can be hired via LAEP. Only students who have accepted a LAEP award will appear in the student field when "Yes" is selected. See <u>the staff facing LAEP website</u> for more information.
      - For non-LAEP work-study hires, indicate "No". Only currently registered students with a current work-study award will appear within the student field.
  - o Indicate non-work-study when hiring a student that applied to a non-work study posting in Handshake.
    - If a student with work study applies via Handshake to a posting which is designated as non-work-study, the student has not authorized the use of work study for this job even if there are work study funds available. Students can authorize work-study by filling out a Work Study Authorization Form, distributed each year in mid-September by the PAT team.
  - o Work Study Selection will drive eligible positions (for example, BYA titles and Resident Assistants are not eligible to be hired under work study positions).

# Step 2 - REQUIRED

- Student Information
  - Users can search by name, CruzID, or Student ID. It is recommended to use CruzID or Student ID as this will reduce the likelihood of selecting the wrong student.
- If a student is not appearing and work study is selected, the student does not have an eligible work study award within the current academic year.
  - o For fall hires, hiring can begin in early September as information will be present for the upcoming term. Exact dates will vary from year to year.
  - o The current work study or LAEP award will be presented once a student is selected.
- If a student is not appearing and work study is not selected, a student is not registered for current term/future term and is not eligible for hire. Students must be currently registered to be eligible for casual-restricted employment.
  - o For fall hires, hiring can begin in early September as information will be present for the upcoming term. Exact dates will vary from year to year.

# Step 3 - REQUIRED

- Preferred Start Date
  - o Date must be the current date or a future date.
    - Even though this should not occur, if there is a need to use a start date previous to the current date, please contact your Timekeeper in regards to the situation.
  - o This date does not indicate actual hire date as students must have completed onboarding prior to starting work.
  - o Students should not begin working until notice of onboarding completion is received.
- Estimated End Date
  - o For work study or LAEP hires, this date will default to work study end date (ex. 06/13/2024), but a later date may be selected.
  - o For other hires, this date should not go beyond the current academic year.
    - For hires made during late spring, it is acceptable to request an end date beyond the current academic year and as far as the



next academic year if it is anticipated that the student will be a registered student.

- For students in continuing jobs, Units can request a job extension via email to their Timekeeper. A new hire request is <u>NOT</u> needed to extend students beyond the date indicated.
  - In addition, PAT will provide extension information to extend student jobs on an as-needed basis.

#### Step 4 - **REQUIRED**

- UCPath Department
  - o This is the department indicated in UCPath. Users will select via department name and this will drive available positions within the system.

#### Step 5 - REQUIRED

• Supervisor



- Supervisor selected should be the person who will be indicated as the "Reports To" within UCPath. This person will also complete the approval of timesheets within CruzPay.
- Supervisor selection is dependent on the UCPath department and access to the HIRES system. Supervisor must be indicated as a hiring manager associated with the selected department to be an available option to display.

#### Step 6 - REQUIRED

- Working Title
  - Working Title should be the same title as advertised within Handshake. This will be used to help students identify the correct job within CruzPay for reporting time.



## Step 7 - REQUIRED for Work-Study or LAEP jobs, OPTIONAL for other jobs

- Handshake Job Posting ID Number
  - For work-study and LAEP jobs you must include the seven digit Handshake job posting ID number (JobID). We highly encourage you to include the JobID for non-work-study jobs. You can find the JobID several ways:
    - You may click the "jobs" tab in your Handshake employer account. The "ID" number is the "ID" number column on the left.
    - You may also find the number when looking at a specific job posting as "Job #".

#### Step 8 – **REQUIRED**

- Hours Per Week
  - o During the academic school year, it is recommended that students work on average less than 20 hrs per week between all jobs.
  - o The hours per week should be the average number of hours per week that is anticipated by this individual.
  - o For BYA jobs, 0 hours per week should be indicated.
  - o LAEP and Work-Study jobs cannot exceed 15 hours per week

- o STDT AID OUTSIDE AGENCY is strictly for use by the Off Campus Work Study department.
- o STDT RSDNC HALLS is used by CHES for Resident Assistants.
- o The respective UCPath job code will display once selected.

  - o The funding for the applicable position should be included here. This information will be transmitted as part of the notification once the position has been created in UCPath.

# Step 13 - REQUIRED

- CANRA, E-Verify, & Background Check
  - o Users will select if the position requires CANRA, e-Verify screening, and background check.

#### Step 14 – **REQUIRED**

- Pay Rate
  - o System will default to the current minimum wage for non-BYA titles.
  - o For 4919 BYAs Please indicate 29.99 as the pay rate. It is required that pay details be provided within the additional pay details section.
  - Other BYA Titles (i.e. 4329, 4331, 9920) Please indicate 0.00 as pay rate. It is required that pay details be provided within the additional pay details section.

# Step 15 – Optional

- Additional Pay Details
  - o BYA Titles Additional pay details should be the same as advertised within Handshake.
    - For example, A \$500 payment will be made at the end of each quarter.
    - Example: May receive up to \$200 every pay period, depending on [description of work completed].
    - BYA positions must still meet California minimum wage requirements.

# Step 16 - Optional

- Comments
  - o The requestor may include any pertinent information in this section that was not covered elsewhere in the form.

## **PAT Review**

PAT will review the request and once processed, the system will determine if the student requires onboarding, background check, or PAT entry to UCPath.

Note - If incomplete or inaccurate data is submitted, PAT might return it to the supervisor for update. If it is returned, a notification will be provided to the supervisor with what updates are required.

This information can also be viewed within the comments section of the request. Once information has been corrected, the user can resubmit the data.

# Unit Position Approval

The unit position approver will receive an email notification to complete approval. If approvals are needed, this will display automatically on the **Manage Hires** page.

The user will click on the student name, and this will display the entire request as submitted by the manager for review by the approver.

Approvers will have the option to approve or reject the position request. When rejecting a position request, it is recommended that the Approver provide comments to explain the rejection.



If approved, the request will route to PAT for creation of the position in UCPath.

If rejected, the request will remain in that state until action is taken.

For updates to pay rate, FTE, and funding, these updates can be made by the hiring manager once rejected and resubmitted for approval.

If other updates are needed (i.e. job duties), the hire request must be rejected and a new hire request submitted.

# **Next Steps**

- Once a position has been created by PAT, the next steps are dependent on job requirements related to a background check and student status in UCPath.
- If the job does not require a background check and the student is not active in UCPath, the student will require onboarding. Notifications will be provided to the student and supervisor.
  - o Work should not begin until <u>Virtual Blue Card</u> is received.
- If a student does not require a background check and is active in UCPath, the student can begin work and notifications will be provided to the student and supervisor.



• After the hire request has been processed within HIRES, funding notifications will be provided with position number, department information, and start/end dates of applicable hire.

# Background Check (Conditional Step)

- If a job requires a background check, the system will route the student for a review by PAT prior to completing onboarding.
- If a student has completed a background check in a previous job, student will be indicated as background check completed and emails will be provided to student and supervisor based on whether or not onboarding is needed.
- If a student requires a background check, the student and supervisor will receive applicable emails providing instruction on how to complete the background process.
  - o Student cannot begin work prior to completing and clearing background check and onboarding (if applicable).
- Once background check results are received and reviewed, the background check will be marked completed in the system.
  - o Student will be provided notifications to determine if onboarding is needed.
